## Installation

#### Installing the Video Adapter

- 1. (Optional) Connect the USB-A to USB-C Adapter to the USB-A Host Connection
- 2. Connect the USB Host Connection to an available USB-A or USB-C port on the Host Computer.
- 3. Connect an HDMI Cable (sold separately) from the HDMI Output 1 on the USB Video Adapter, to an HDMI Display.
- 4. Connect an HDMI Cable (sold separately) from the HDMI Output 2 on the USB Video Adapter, to an HDMI Display.
- 5. Arrange the display using the operating system's **Display Settings**.

### Operation

#### **Change Display Settings in macOS**

Intel Based Mac Devices

To change the **Screen Rotation** or other **Settings**, use the operating system's **Display Settings**.

M1/M2 Based Mac Devices

To Mirror/Extend the connected displays, use the InstantView App. The InstantView App is accessible by Single Clicking the InstantView App Icon in the Menu bar.

To change the **Screen Rotation** or other **Settings**, use the **InstantView App** by **Right Clicking/Double Clicking** the **InstantView App Icon** in the **Menu Bar**, which will bring up a variety of available settings.
